Documents

- Complete application form
- CV/resume in English
- Copy of passport
- 2 letters of recommendation

Qualifications

- UK undergraduate degree or equivalent
 - A selection of professional qualifications will be considered for admissions
- GMAT is not an obligatory requirement but is considered an advantage
GMAT may be required for some full-time applications. Target Score: 550

English proficiency options

- IELTS - 6.5 (minimum: 5.5 in each component)
- PTE - 59 (minimum: 51 in each component)
- TOEFL (IBT) - 91 (minimum: L-21, R-22, S-23, W-21)

Experience

Work experience is not an obligatory requirement but is considered as an advantage. We recommend 3 years of full-time work experience prior to joining the programme.
